Subscriber Subscription Terms and Conditions

Version 1.0 | Effective: 2026

This document sets out the Terms and Conditions for joining **Photo Venture Nepal (PVN)** and its community initiative **Nepalese in Photography (NIP)**, referred to below as "**PVN**", "**we**", or "**us**". These terms form the contract between us, so please read them carefully.

These Terms and Conditions apply to all Subscribers of PVN, except for clauses relating to subscription fees and paid subscription benefits, which apply only where a subscription fee is payable.

By applying for, enrolling in, or maintaining a subscription, you agree to comply with these Terms and Conditions in full.

1. Eligibility

- 1.1 Subscription access is open exclusively to registered Subscribers of PVN.
- 1.2 Applicants must provide accurate, complete, and up-to-date information.
- 1.3 PVN reserves the right to accept or reject any subscription application at its sole discretion without obligation to provide a reason.
- 1.4 Subscription access is personal and non-transferable.

2. Subscription and Payment

- 2.1 Subscription fees are payable in advance for the selected subscription period.
- 2.2 All payments must be completed through approved PVN payment methods.
- 2.3 Subscription access will not be activated until payment is successfully received.
- 2.4 Fees are non-refundable except where explicitly stated in Section 8.
- 2.5 Subscription includes participation in one (1) Annual Photography Competition during the subscription validity period.

3. Subscription Benefits

Subscribers participating in PVN subscription activities may gain access to creative recognition, professional development, and community opportunities.

3.1 Recognition & Visibility

- Recognition through awards, certificates, and official announcements (where applicable)
- Increased visibility through showcases, social media features, exhibitions, or publications organised by PVN
- Portfolio enhancement through selected works and achievement acknowledgements

3.2 Learning & Creative Growth

- Constructive feedback and evaluation from judges, mentors, or reviewers (where applicable) •
- Opportunities for skill development through thematic challenges and curated activities •
- Creative motivation through participation alongside other dedicated photographers

3.3 Networking & Opportunities

- Networking opportunities with photographers, creators, judges, sponsors, and industry professionals
- Access to exclusive events, workshops, talks, or Subscriber-only activities
- Potential opportunities for collaborations, sponsorships, internships, assignments, or ambassador roles for outstanding contributors

3.4 Rewards & Community

- Access to exclusive prizes, merchandise, partner offers, discounts, or other Subscriber-only rewards
- Community recognition within PVN platforms and partner networks

PVN reserves the right to modify, expand, or remove any subscription benefits at any time without prior notice.

4. Subscriber Responsibilities

- 4.1 Act in a respectful and professional manner within all PVN platforms and events.
- 4.2 Not misuse PVN resources, branding, or community platforms.
- 4.3 Ensure all submitted content is original or properly credited.
- 4.4 Comply with all applicable laws and regulations.
- 4.5 Avoid any behavior that may harm PVN's reputation or community integrity.

5. Content Submission Rights

- 5.1 Subscribers retain full ownership of their submitted content.
- 5.2 By submitting content, Subscribers grant PVN a non-exclusive, worldwide, royalty-free license to: •
 - Display content on PVN platforms, RONB, Canon Nepal, and Xiaomi Nepal platforms or associated media channels
 - Promote exhibitions, competitions, and community activities
 - Archive content for record and institutional purposes
- 5.3 PVN will always credit the original creator where reasonably possible.

6. Code of Conduct

Subscribers must not:

- Engage in harassment, discrimination, or abusive behavior
- Upload illegal, offensive, or copyrighted material without permission
- Misrepresent identity or professional credentials
- Disrupt events, competitions, or community platforms
- Attempt unauthorised access to PVN systems or data

Violation may result in suspension or termination of subscription access.

7. Subscription Duration and Renewal

7.1 Subscription access is valid for the duration selected at registration.

7.2 Renewal reminders may be issued prior to expiry.

7.3 Failure to renew will result in suspension of subscription benefits.

8. Cancellation and Refund Policy

8.1 Subscribers may cancel subscription access at any time; however, fees already paid are generally non-refundable.

8.2 Refunds may be issued only in exceptional cases at PVN's discretion, such

as:

- Duplicate payment

- Technical or processing errors

- Verified administrative mistakes

8.3 PVN reserves the right to terminate subscription access in case of violation of these Terms.

9. Suspension and Termination

PVN may suspend or terminate a Subscriber's subscription access if:

- These Terms and Conditions are violated

- Misuse of subscription privileges occurs

- Fraudulent or misleading information is provided

- Conduct harms the reputation or operations of PVN

Termination may occur immediately and without prior notice in serious cases.

10. Privacy and Data Protection

10.1 PVN collects personal data only for subscription administration and operational purposes. 10.2

Personal data will not be sold or shared with third parties without consent, except where required by law.

10.3 Subscribers may request access, correction, or deletion of personal data subject to legal and regulatory requirements.

11. Limitation of Liability

11.1 PVN is not liable for any indirect, incidental, or consequential losses arising from subscription participation.

11.2 PVN does not guarantee specific outcomes from participation in events, competitions, or programs.

11.3 All participation is undertaken at the Subscriber's own risk.

12. Amendments to Terms

12.1 PVN reserves the right to update or modify these Terms at any time.

12.2 Updated Terms will be published through official PVN platforms.

12.3 Continued subscription access constitutes acceptance of revised Terms.

13. Governing Law

These Terms and Conditions are governed by the laws of **Nepal**. Any disputes shall be subject to the jurisdiction of the courts of Nepal.
